



2024 MEMBER IMPACT FUND

FEDERAL HOME LOAN BANK OF DES MOINES

In March 2024, FHLB Des Moines awarded \$20 million in voluntary contributions to the Member Impact Fund. Through this voluntary program, FHLB Des Moines provided a \$3 matching grant for every \$1 in grant funds that a member committed for working capital or capacity building funds to support not-for profit or government agencies' affordable housing or community development mission.

Eligible locations included Hawaii, Montana, North Dakota, Oregon and the Bank's three U.S. territories of American Samoa, Guam, and the Commonwealth of the Northern Mariana Islands.
